20933	<p>Mr. Martin Brown from the ‘delivery team’ at Essex County Council, gave a short talk on the plans for how the construction work is to be carried out on the extension at Elsenham Primary School.</p> <p>The contractor is Kier, they will commence in April 2018 and finish in the summer 2019. There are several problems that need to be addressed before work commences, but mainly parking and access.</p> <p>Kier have been asked to produce an Inspection Management Plan.</p> <p>There will be no construction or delivery vehicles entering or leaving the school grounds during the school’s drop off and pick up times.</p> <p>Highways are placing an enforcement order of ‘No Parking’ in the High Street, and the Zebra Crossing is being moved.</p> <p>The Council pointed out that it was unrealistic to think that the construction vehicles could park at the Church, this is a very narrow lane with no turning room.</p> <p>It was suggested that Kier arrange for their contact details to be given to the Parish Clerk.</p>

20934	<p>Mr. Gary Bentley had asked Uttelsford District Council (UDC), through the Freedom of Information Act, out of the 12,500 homes being built in Uttlesford, how many warden assisted flats for the elderly are being built. UDC answered that there were no flats for the elderly, only bungalows which can be purchased by anyone. Mr. Bentley said that this was discrimination. Mr. Bentley had also written to our MP Mrs. Kemi Badenoch three times, but had received no reply.</p>

A meeting is being held on 20 March 2018 with Highway Officers, Education Officers and Fairfield to assess the Fairfield planning application. RF asked if New Road could be added to the roads that are gritted, this is a major road in and out of the village and services many houses, yet it is never gritted.</p>	<p>RG to investigate this.</p>
20938	<p>District Councillors report PL said the salt for gritting the paths in the village had been a remarkable success, there were only ten bags left. The snow had caused some disruption for bin collection. Four additional crews were working to clear the backlog. In UDC's 5 year financial plan, the budget for waste collection was not being increased; PL is to question this. The request for extra dog bins in the village has always been refused, as UDC will not take on the responsibility of emptying them. However, dog waste may be put into</p>

20940	<p>Housing Development in Elsenham</p> <p>Community Building Land PJ and GM had a meeting with Nigel Brown from UDC. At the time of the meeting Nigel Brown had still not approached Crest Nicholson regarding the ransom-strips. However, Nigel Brown was confident that UDC would be able to resolve the situation. A deadline for the meeting by the end of May 2018 was agreed.</p> <p>Bovis Homes Planning Appeal The Bovis Homes planning appeal is scheduled for 27 March 2018. The hearing is to be a more informal approach. A UDC Planning Officer will be present, which suggests UDC will be defending their earlier decisions. EPC had informed UDC that their planning portal contained only part of the officer’s report, and asked for a full copy, which UDC have now supplied. This will help determine whether EPC wishes to formulate a further response to the Inspector, ahead of the hearing.</p> <p>PL, GL and RG left the meeting.</p> <p>Fairfield – Proposed 350-Homes Development The proposed ‘Joint Parish Council Steering Group’ (JPCSG), meeting with Essex Highways had been postponed. The meeting is to be re-scheduled, GM will attend.</p> <p>DWH Development (Kingswood Place) – New Streets Naming & Numbering DWH have suggested some names for the new streets on their development. EPC however, would like to continue using the names of the men from Elsenham that lost their lives in conflict. It was agreed to put forward as the names for the new streets on the Nursery development, Oak Drive, Hawthorn Close, Ash Close and Maple Close. These are the names of the many trees that have been cut down, in order for this development to proceed.</p>	PEC to send the names to LJ.

It is hoped that the cost to rectify it, will be paid by the developers and not the rate payers.</p> <p>All three developments have wheel washers, but these make the mud flow from the sites onto the paths and road. Most of the drains are blocked due to the mud, there are lots of deep pot holes, the GPO drain cover needs to be replaced again and the pavements all need sweeping.</p> <p>Isabel Drive pavement on DWH site is not flush, making a trip hazard.</p> <p>The vehicles driving onto the Nursery site have to drive over the pavement which is now breaking up.</p>		<p>LJ to write to DWH.</p> <p>LJ to write to the Nursey development.</p>
