22148	It was asked if EPC would be doing anything to celebrate the Queens Platinum Jubilee.	EPC to discuss.
22149	Church Lane and Hall Road are still covered in mud due to the work being carried out in the field adjacent to the St. Mary’s Church allotments. This has been reported to Essex Highways, Cllr. Ray Gooding and the owner of the land.	LJ to contact Cllr. Ray Gooding again.
22150	The ECA meeting due to take place on Thursday 13th January has been postponed, the meeting for all Trustees and Interested Parties will be held on Thursday 10th February 2022. 22152	It was thought that allowing co-opted members to chair committees and working groups was not a good idea. They do not attend the Parish Council meeting and therefore would not be able to give a report. GM said this had worked perfectly well with EROWOS for many years. Paul Salvage was chairman	

	and GM gave the report at the Parish Council meetings. The same will apply if Moyra Jackson is chairman of the Flowerbeds Committee, SW will give the reports.	
22153	It was reported that the Remembrance Service held in and around the Memorial Garden, which is organized by the church, was very well attended, however people were spilling onto the path and nearly onto the road, this made it dangerous: there was only one marshal in a high-vis jacket.	LJ to write to the church regarding these concerns. As the village continues to grow the service may have to be moved to De Mandeville Green.
22154	<p>There was disapproval regarding a meeting held on 1 October 2021 with GM, SW, LJ and 6 representatives from Bloor Homes. The meeting was held onsite and ended with lunch at the Crown Inn. The resident said the Parish Council should be seen to do the ‘right thing’. Residents in Elsenham had fought to stop this development for over 10 years and for members of EPC to accept a meal paid for by Bloor was not right.</p> <p>GM responded that at the time of the meeting Bloor already had approval for outline planning permission. EPC had opposed this development at all stages. GM had spoken against this planning application at the appeal and gave an opening and closing statement. GM had attended a UDC planning meeting with Bloor, as he had so many questions to ask it was agreed that a separate meeting with Bloor would take place, to make things clearer the meeting would take place on site. As it is difficult to make notes walking around a development site in a large group, the meeting adjourned to outside at the Crown Public House to discuss the issues that had been raised. It was asked why the meeting was not held at Old Franks. GM said because of Covid and the amount of people at the meeting this would not have been appropriate.</p>	
22155	Allan Hathaway said that GM had put in more work than anyone in the village to try and stop this development and talking about this issue was nonsense and a waste of time.	
22156	Chris Bush asked for a copy of the new Elsenham boundary plan in order to update the History Society website, the last time the boundary changed was 1946. The plan is currently with UDC.	GM to make the plan available.

22158	Minutes Council to consider the minutes of the meeting held on 6 December 2021. Minute 22143 was amended to read Praise was given to the professionalism.	The minutes were approved by EPC, as a true and accurate record and signed by the Chairman.
22159	District Councillor's report There are currently 10 unallocated allotments on Smith Road. BD asked GL if some funds from the Ward Initiative Fund could be used to pay the rent for these allotments, so charities could use them free of charge. GL said the allotments were owned by EPC, and the money could only be given to charities, however, GL said he would look further into the matter. EPC agreed in principle that allowing charities to use the allotment plots funded by the Ward Initiative Fund was a good idea. There are however stipulations in the allotment management procedures and policies document which may require addressing. Two independent experts are to look at UDC's process of the Stansted Airport planning application. GM asked GL to inform him, when the information becomes available, who the external experts are, and their terms of reference. GL said UDC should be in a position for a public report sometime in the spring. The crime reports for the district shows very little crime in Elsenham and Henham. EPC may like to look into funding a Special Police Officer, rather than a PCSO. Special Police Officers have full police powers, uniform and equipment. GM said EPC would give some serious consideration on whether to re-new the PCSO contract when it expires in August 2022.
