Parish Council Chairman's report

UTT/21/2461/DFO Land To The West Of Isabel Drive Elsenham on two sites.

(FP31 & FP32) (Dandara Eastern 99 homes)

The route of FP31 was blocked by Heras fencing. Dandara removed the blockage when requested to do so by EPC.

EPC will continue to monitor the S106 conditions including

FP31 Improvements to be done prior to first occupation.

FP32 Dandara to make a contribution to ECC who will do the required work. EPC has asked for us to be kept informed when the contribution is made, so we can pursue.

EPC has asked for sight of Dandara Alsa Wood Management Plan.

GM will pursue the removal of the barbed wire.

UTT/19/0462/FUL Land West Of Hall Road (FP13) (Bovis Homes 130 homes)

Work is beginning and the developers have met with Ned Gemmill (ECC PRoW Office) (NG).

ECC have sent EPC details of an informal consultation on a permanent diversion of FP13. This would route FP13 on estate roads and not through the "green buffer" as detailed on the approved planning application.

EPC will object strongly.

UTT/21/3269/DFO - Land To The North West Of Henham Road

(FP21 Elsenham, FP15 Henham) (Bloor Homes Phase 1 350 homes) Ongoing

UTT/20/2908/OP Land South of Bedwell Road

(FP29 Ugley) (Rochester Properties 50 homes)

The application was approved upon appeal. Improvements to FP29 Ugley are planned.

UTT/19/0437/OP Rush Lane

(FP29 Elsenham)

This planning permission will lapse in September 2023.

PINS Section 62A Application: S62A/22/0007 Land to the South of Henham Road

(FP13 Elsenham) (Countryside Properties 130 Homes)

Planning application approved. FP13 should be maintained.

Section 62A Planning Application: S62A/2022/0012 - Land East of Station Road, Elsenham

(FP15 Henham) (Bloor Homes Phase 2 - 200 houses adjacent to UTT/21/3269/DFO) Detailed application awaited.

Bloor homes have said that there will be a pathway running around the perimeter of their site, which will follow the line of the route that is currently walked.
