EROWOS contributed to the EPC stall at Elsenham Village Fete Saturday 22nd June 2024.

A UDC tree surgeon has cut well back the dying Oak Tree on Broom Farm Road.

Parish Council Chairman's report

UTT/21/2461/DFO Land To The West Of Isabel Drive Elsenham on two sites.

(FP31 & FP32) (Dandara Eastern 99 homes) Dandara will be contacting Sam Blackwell at ECC to discuss how they can pay their S106 contribution (£12,075 indexed linked since April 2020) to pay for the improvements to FP32. GM reported that FP31 is being improved in line with building of new houses. EPC have drawn this to UDCs attention as it is was agreed in the planning consent that the improvement would be completed before first occupation.

UTT/23/2804/DOC Land To The West Of Isabel Drive Elsenham

Application to discharge condition 12 (woodland management plan)

The revised Dandara Alsa Wood Management Plan was not discharged by UDC as it was inadequate.

UTT/24/0910/DOC Land To The West Of Isabel Drive Elsenham

Application to discharge condition 14 (recreation strategy) attached to UTT/19/2470/OP EPC have responded to point out shortcomings in the application.

UTT/19/0462/FUL Land West Of Hall Road (FP13)

(Vistry Eastern Bovis Homes 130 homes) FP13 is still closed. The closure order will expire on 1th September 2024.

UTT/21/3269/DFO Land To The North West Of Henham Road (FP21)

Walkway from site to Elsenham station is underway although still not open despite > 100 houses occupied.

S62A/2024/0049 (previously UTT/20/2908/OP) Land South of Bedwell Road Ugley

(FP29 Ugley) (Rochester Properties 50 homes) Detailed Planning Application submitted to PINS. Representations on detail should be made by 6th August 2024.

S62A/2023/0026 UTT/23/2622/PINS Robin Hood Road

(FP29 Elsenham) (40 Dwellings) Planning Application approved by PINS - with site access from the turning bay by the railway line. No detailed application has been submitted, however **UTT/23/2028/DFO Rush Lane**

Detailed Planning Application will be before the UDC Planning Committee shortly

PINS Section 62A Application: S62A/22/0007 Land to the South of Henham Road

(FP13 Elsenham) (Countryside Properties 130 Homes) Detailed Planning Application awaited.

UTT/23/2063/DFO Land East of Station Road

(FP15 Henham) (Bloor Homes Phase 2 - 200 houses) Detailed Planning Application agreed by UDC.

Uttlesford Local Plan - Land East of Station Road, Elsenham (in Henham Parish).

The Regulation 19 LPP Draft includes a new provision of 110 homes adjacent to Bloor Homes Phase 2. This will take the development up to the line of FP15.

UTT/24/ 0543/OP Land North Of Bedwell Road & East Of Old Mead Road Ugley & Henham

(FP32 Henham & FP14 Ugley) (Gladman 240 homes)

EPC has suggested that Elsenham (as well as Ugley & Henham) should be included in the S106 provisions, and include PRoW creation in line with TWAO March 2022.

Hall Road

Development at Elsenham Stables. There is a proposal to develop the land South of Daisy Mays Farm for a leisure centre. A Planning Application has not yet been submitted. This would potentially create public access to the lake and parkland therein.

Tye Green Sarsen stone

DV has plotted the original position of the stone and suggests it be moved to the churchyard. EPC to decide in discussion with SP.

HS will be spreading some more seeds. Action: HS

New Road Wildflower Area

KW has spoken to Paul Dooley Biodiversity Officer at UDC.

EPC have agreed that their land at the corner of Alsa Gardens should become a Wildflower area.

Rights of Way

MS has been in contact with Ned Gemmill (NG) at ECC to enquire when the Annual Cut is scheduled to take place. No response as yet.

Overgrown Paths **FP12/FP13/FP15/FP26/FP28/FP45** - These are all on the Annual Cutting List so we will leave them to ECC.

FP14 / Other waymarkers & missing fingerposts DV & SW will investigate. Action: DV/SW

FP22 / FP15 Henham ref 2918716 becoming overgrown but KW is monitoring.

FP28 ref 2909442 ECC have refused to repair broken handrail. Someone has laid down paving stones, which has made the path safer to navigate. No further action.

FP35 (Catts lane) it is an area of hemlock not hogweed that is problematic. ECC refuse to take any remedial action. HS to include a warning in her next article in Elsenham News **Action: HS**

Tree Warden's Reports

There are 3 Whitebeams on Station Road that are suffering from honey fungus. MS to ask NG who has taken over from Joseph Beznosniuk at ECC arboriculture.
